

Privacy Statement

Welcome to www.thejournalofprecisionmedicine.com! This Web Site (this "Site") is owned and operated by Kneed Media LLC, (KM, "we" or "us"). KM is a leader in providing B2B solutions to the Global Life Sciences industry.

We are committed to respecting the personal privacy of the individuals who use this Site and its mobile properties. This Privacy Statement (this "Privacy Statement") describes our current policies and procedures in respect of personal information we collect through this Site. The term "personal information" means individually identifiable information about an individual collected through this Site, such as, the name, age, telephone number, e-mail address or mailing address of that individual.
